**Resolution 1 (2021)**

**Adopted by the Member States that consist of**

**In Funairi Model United Nations on 11 January 2022**

---

**To protect Human Right,**

**The Security Council's**

***Keeping* peaceful lives by increasing the budget for the PKF and attending the military operations more actively,**

***Emphasising* again that the Myanmar government which led by the Myanmar military is illegal,**

***Excluding* the Myanmar military government from any international leagues,**

***Sending the United States Marine Cops to Myanmar to deal with suppression of the Myanmar military,***

***Supporting and approving the democratic Myanmar government,***

***Recognising the situation in Myanmar as an illegal suppression of people who hope to establish a democratic government by election,***

***Monitoring Myanmar to prevent conflicts after the official government is in place,***

***Making positive actions towards the illegal government by countries opposing to dictatorship (Countries which disagree with dictatorship should make some positive actions to the illegal government),***

**And the Peacebuilding commission's**

***Supporting Myanmar mainly with supplies and not using armed forces,***

***Creating the bond between EU and Turkey by holding conferences on whether or not Turkey joins EU, in exchange of accepting refugees coming from Middle East into the countries a part of EU (PBC bonds EU and Turkey to make a conference about Turkey joins EU, in exchange of accepting refugees coming from European countries that are members of EU),***

***Putting more personnel for the education, medicine, advancing technologies of the countries which need help into the PBC by advanced countries such as G7 or the countries which have a high rate in GDP,***

***Putting Myanmar under PBC observation to avoid conflicts within the country after the official government has taken place,***

***Taking Myanmar citizens votes in order to decide the official government of the country without using the military to suppress Myanmar's problems (PBC),***

**And the UNHCR's**

***Controlling the number of refugees in seriously overpopulated countries from other countries,***

***Supplying food, medicine, education, and so on to Syrian refugees.***

**To make the peaceful world,**

**The Human Rights Council,**

***Proclaiming*** that all people on the earth have rights to receive enough medical care equally,

***Calling*** to stop wars towards military-conflict areas to supply enough medical care,

***Promoting*** travel by the system of giving ticket or present people who pay money for the country,

***Introducing*** the cultural education curriculum into the compulsory education,

***Sharing*** the accurate information of discriminated people such as indigenous people in order to understand other cultural backgrounds by the UN on any media.

**And the WHO's**

***Expressing*** one's appreciation to health care professionals who engage in treatments of COVID-19,

***Encouraging*** more vaccine approval to protect human rights to choose which vaccine to get,

***Making*** insurance for all people to promote taking vaccine,

***Making*** crowd funding to gather funds to make insurance that all people can take vaccine and after medical care,

***Increasing*** rate of taking vaccine by providing more helpful information about the benefit of COVID 19 vaccination,

***Making*** new rule about wearing mask.
